RESOLUTION NO. 109 S. 2020

AUTHORIZING THE CITY MAYOR TO GIVE FINANCIAL ASSISTANCE TO THE 105 BARANGAYS OF BATANGAS CITY AND OTHER MARGINALIZED SECTORS

WHEREAS, the Batangas City Government now stands against the disabling effects of the enhanced community quarantine mandated under Proclamation 292 which declared a state of calamity throughout the Philippines;

WHEREAS, cognizant of the difficulties faced by the constituents borne by strict quarantine measures, the City Government explores all available avenues to buffer the blow to its people, and ameliorate their livelihood;

WHEREAS, authorized under Proclamation 292 and by the guidelines, memorandum circular, and other directives from the national government and the Inter-Agency Task Force on Emerging Infectious Diseases, the City Government of Batangas acknowledges the necessity of providing financial assistance to its constituents;

NOW, THEREFORE, be it resolved as it is hereby resolved by the Sangguniang Panlungsod in session assembled, to grant authority to the City Mayor to give financial assistance to the 105 Barangays and other marginalized sectors of Batangas City as follows:

- The amount of Twenty Thousand Pesos (PhP 20,000.00) for each of the 105 Barangays of Batangas City.
- The amount of Two Thousand Pesos (PhP 2,000.00) for every holder of legitimate tricycle franchise in Batangas City.

Continuation of Resolution No. 109 S. 2020

AUTHORIZING THE CITY MAYOR TO GIVE FINANCIAL ASSISTANCE TO THE 105 BARANGAYS OF BATANGAS CITY AND OTHER MARGINALIZED SECTORS

RESOLVED FURTHER, that the financial assistance shall be sourced from the Quick Response Fund of the current year Calamity Fund of Batangas City;

RESOLVED FURTHERMORE, that appropriate guidelines for the release of this financial assistance shall be issued by the concerned agencies, and shall be in accordance with pertinent accounting and auditing laws, rules and regulations.
