WHEREAS, the City Government of Batangas has to respond to the exigencies wrought by COVID19 pandemic and prudence calls for preparedness in all aspects of the prevailing emergency;


WHEREAS, protocol of the Department of Health requires that Covid19 death cases should be yielded to cremation;


WHEREAS, there is no cremation facility in Batangas City deemed capable of performing the service for Covid19 death cases;




