RESOLUTION NO. 113 S. 2020

**APPROVING A SPECIAL USE PERMIT FOR SAN FERNANDO FUNERAL HOMES,
INC. TO ESTABLISH, MAINTAIN, AND OPERATE A CREMATORIUM IN ITS
FACILITY IN BATANGAS CITY AND AUTHORIZING THE CITY MAYOR TO
ISSUE THE SPECIAL USE PERMIT FOR THIS PURPOSE**

WHEREAS, the City Government of Batangas has to respond to the exigencies wrought by COVID-19 pandemic and prudence calls for preparedness in all aspects of the prevailing emergency;

WHEREAS, protocol of the Department of Health requires that COVID-19 death cases should be yielded to cremation;

WHEREAS, there is no cremation facility in Batangas City deemed capable of performing the service for COVID-19 death cases;

WHEREAS, San Fernando Funeral Homes has manifested a capability and willingness to tie up with the Batangas City Government for the provision of cremation services should the need arises, under terms and conditions acceptable to all parties;

WHEREAS, there is a need for the City Mayor to issue a Special Use Permit to San Fernando Funeral Homes to provide the needed service;


NOW THEREFORE, be it resolved as it is hereby resolved by the Sangguniang Panlungsod in session assembled, to approve as it hereby approves a Special Use Permit for San Fernando Funeral Homes, Inc. to establish, maintain, and operate a crematorium in its facility in Batangas City and to authorize the City Mayor to issue the Special Use Permit for this purpose;


