**AUTHORIZING THE CITY MAYOR TO ENTER INTO AGREEMENT WITH  
NATIONAL GOVERNMENT AGENCIES FOR THE IMPLEMENTATION OF THE  
SOCIAL AMELIORATION PROGRAM UNDER JOINT MEMORANDUM CIRCULAR  
NO. 1 SERIES OF 2020 OF THE INTER-AGENCY TASK FORCE FOR THE  
MANAGEMENT OF EMERGING INFECTIOUS DISEASES (IATF-EID)**

**WHEREAS**, Proclamation No. 922 by President Rodrigo Roa Duterte declared a State of Public Health Emergency throughout the Philippines due to the outbreak of the Coronavirus Disease or COVID-19 which now has become a global pandemic;

**WHEREAS**, succeeding Proclamation 929 by the President declared a State of Calamity Throughout the Philippines Due to Corona Virus Disease 2019 authorized and mobilized the national and local disaster operations resources with the common objective of providing the necessary health and livelihood assistance to constituents most affected by the calamity;

**WHEREAS**, the Inter-Agency Task Force on Emerging Infectious Diseases (IATF-EID) issued Joint Memorandum Circular No. 1 Series of 2020 providing for the Special Guidelines on the Provision of Social Amelioration Measures by the DSWD, DOLE, DTI, DA, DoF, DBM, and DILG to the Most Affected Residents of the Areas Under the Enhanced Community Quarantine;

**WHEREAS**, on March 30, 2020, the Department of the Interior and Local Government issued Memorandum Circular No. 2020-065 providing for the Guidelines for Local Government Units in the Provision of Social Amelioration Measures by the National Government to the Most Affected Residents of the Areas Under Enhanced Community Quarantine;

**Continuation of Resolution No. 114 S. 2020**

**AUTHORIZING THE CITY MAYOR TO ENTER INTO AGREEMENT WITH NATIONAL GOVERNMENT AGENCIES FOR THE IMPLEMENTATION OF THE SOCIAL AMELIORATION PROGRAM UNDER JOINT MEMORANDUM CIRCULAR NO. 1 SERIES OF 2020 OF THE INTER-AGENCY TASK FORCE FOR THE MANAGEMENT OF EMERGING INFECTIOUS DISEASES (IATF-EID)**

Dimacuja, to enter into Memorandum of Agreement with the concerned National Government Agencies for the effective implementation of the Social Amelioration Programs of the National Government for the people of Batangas City;


**RESOLVED FURTHER**, to authorize the City Mayor to execute, sign, and submit all necessary agreements and documents necessary for the effective provision of the social amelioration benefits to the constituents of Batangas City;
