## RECOGNIZING HEALTH WORKERS AND FRONTLINE WORKERS AS HEROES OF THE COVID-19 PANDEMIC AND URGING THE PUBLIC AND PRIVATE SECTORS TO ENSURE THEIR COVERAGE WITH PHYSICAL AND ECONOMIC BENEFITS GRANTED UNDER THE LAW

WHEREAS, Batangas City is not spared from the paralyzing effects of the COVID-19 pandemic and as the nation grapples from socio-economic backlash of this emergency, the country's institutions providing health and other frontline services are evidently overburdened;

WHEREAS, exposure to life-threatening risks notwithstanding, frontline workers of Batangas City have remained steadfast in performing their bounden duty to care for the sick, provide surrogate families to their patients during this time of extraordinary health crisis and provide the most needed services to communities to buffer the effects of the Enhance Community Quarantine;

WHEREAS, the Proclamation of State of Public Health Emergency Throughout the Philippines Due to COVID-19, the Bayanihan to Heal as One Act, and other current issuances of the National Government agencies, emphasize the declared policy of the State to promote the welfare of our frontline workers through the provision of benefits under the Magna Carta of Public Health Workers, provision of Special Risk Allowance, payment of Hazard Pay in accordance with existing labor legislations, absolute medical expenses coverage by the PhilHealth Insurance Corporation in cases of exposure to COVID-19 or any work-related injury or disease during this health emergency, and payment of compensation by the government to public and private health workers who may contract or die from severe COVID-19 infection while in the line of duty;
