WHEREAS, Batangas City is seeking the assistance of the Philippine National Red Cross to provide the people of Batangas City efficient COVID-19 laboratory testing services;

WHEREAS, the City Mayor needs the authority to enter into agreement with the PNRC for the purpose;

UNANIMOUSLY APPROVED.


