**APPROVING AND DECLARING OPERATIVE THE SUPPLEMENTAL BUDGETS
FOR CALENDAR YEAR 2020 OF DIFFERENT BARANGAYS OF BATANGAS CITY**

WHEREAS, a review of the Supplemental Budget for Calendar Year 2020 of different Barangays of Batangas City shows substantial compliance with the provisions of the Local Government Code of 1991;

NOW THEREFORE, be it resolved, as it hereby resolves, to approve and declare operative the Supplemental Budgets for Calendar Year 2020 for the purpose the amount was appropriated:

2. Catandala	103,795.37
3. Malibayo	509,317.05
4. San Antonio, Isla Verde	493,895.80
5. Simlong	5,253,587.05
6. Sto. Niño	718,844.40

RESPONSIBILITY. The execution of the budget and the accountability therefore shall be vested primarily in the Punong Barangay.

COMPLIANCE. Compliance to the provisions of the Budget Operations Manual for LGUs issued by the Department of Budget and Management and Commission on Audit and to all auditing rules and regulations are hereby mandated.



UNANIMOUSLY APPROVED by the Sangguniang Panlungsod on June 16, 2020.”


