Application for Zoning/Locational Clearance of Globe Telecom, Inc.

Referred to the Committee on Environment, Urban Development Land Use and Zoning is the application for zoning/locational Clearance of Globe Telecom, Inc. for its proposed twelve (12.00) meter high tripod tower (cell site) to be installed at the top of existing building located at Lot 3 #30 Sampaguita St., corner Jasmine St., Dolor Subd., Brgy. Poblacion 6, Batangas City. The property is on lease to Globe Telecom by owner Arthur R. Torres.

The project site is within the designated Primary Urban Core Zone-2 (PUCZ-2) per the Batangas City Zoning Ordinance. The proposed 12.00 meter high tripod cell site tower is a complementary use in PUCZ-2. The Sangguniang Barangay of Poblacion 6 issued Resolution No. 6 S. 2019 stating that the Sangguniang Barangay interposes no objection to the proposed project. Consequently the Sangguniang Barangay also issued a certification allowing Globe Telecom to operate in the barangay. The residents within 50 meters from the project location signed a letter stating that they do not object to the proposed project.

Other national agencies concerned such as the Center for Device Regulation Radiation Health and Research of the Food and Drug Administration, Department of Health (CDRRHR-FDA-DOH), Civil Aviation Authority of the Philippines (CAAP) and DENR-Environment Management Bureau CALABARZON, all issued respective clearances in favor of the proposed cell site tower project.

RECOMMENDATIONS:

The Committee finds no legal impediment for the approval of the instant application for Zoning/Locational Clearance of Globe Telecom, therefore the Committee recommends its approval subject to compliance to all applicable laws and Batangas City ordinances most

specially, the Batangas City Environment Code, and health, safety, and general welfare ordinances.

The committee also recommends the adoption of this Committee Report.
