**APPROVING AND DECLARING OPERATIVE THE SUPPLEMENTAL BUDGET
FOR CALENDAR YEAR 2020 OF BARANGAY PINAMUCAN IBABA,
BATANGAS CITY**

WHEREAS, a review of the Supplemental Budget for Calendar Year 2020 of Barangay Pinamucan Ibaba, Batangas City shows substantial compliance with the provisions of the Local Government Code of 1991;

NOW THEREFORE, be it resolved, as it hereby resolves, to approve and declare operative the Supplemental Budget for Calendar Year 2020 for the purpose the amount was appropriated:

EFFECTIVITY. The approved Supplemental Budget of the Barangay shall take effect upon approval by the Sangguniang Barangay concerned or on the date fixed in the Barangay Ordinance as provided in Article 416 IRR and Section 332 LGC.


Certified copy of this resolution shall immediately be furnished to the concerned Sangguniang Barangay, through the Punong Barangay and to the City Budget Officer.


