RESOLUTION NO. 285 S. 2020

**APPROVING AND DECLARING OPERATIVE THE SANGGUNIANG KABATAAN
ANNUAL BUDGETS FOR CALENDAR YEAR 2020 OF BARANGAYS CALICANTO
AND CATANDALA, BOTH OF BATANGAS CITY**

WHEREAS, a judicious review, evaluation and analysis of Sangguniang Kabataan Annual Budgets of Barangays Calicanto and Catandala, both of Batangas City submitted to the Sangguniang Panlungsod shows substantial compliance with law and all budgetary rules and regulations.

NOW THEREFORE, be it resolved as it hereby resolves, to approve and declare operative the Sangguniang Kabataan Annual Budgets for Calendar Year 2020 to wit:

1. Calicanto	996,895.00
2. Catandala	222,973.00

The budget documents shall form part of the authorized Sangguniang Kabataan budget.

Any change in the annual budget shall be in accordance with the provisions of Sections 321 and 336 of the Local Government Code.

Compliance with all existing laws, auditing rules and regulations are hereby mandated and shall be the responsibility of the Sangguniang Kabataan officials.

These Sangguniang Kabataan budgets are therefore considered operative and effective as of January 1, 2020 in accordance with Section 332 of R.A. 7160.


