**APPROVING AND DECLARING OPERATIVE THE 2020 SANGGUNIANG
KABATAAN SUPPLEMENTAL BUDGETS OF VARIOUS BARANGAYS OF
BATANGAS CITY**

WHEREAS, a judicious review, evaluation and analysis of the Sangguniang Kabataan Supplemental Budgets submitted to the Sangguniang Panlungsod shows substantial compliance with law and all budgetary rules and regulations.

NOW THEREFORE, be it resolved, as it hereby resolves, to approve and declare operative the Sangguniang Kabataan Supplemental Budgets for the purpose the amount was appropriated:

RESPONSIBILITY. The execution of the budget and the accountability therefore shall be vested primarily in the Sangguniang Kabataan (SK) Chairman.

Compliance to the provisions of Joint Memorandum Circular No. 1 S. 2019 or the Guidelines on the Appropriation, Release, Planning and Budgeting Process of Sangguniang Kabataan (SK) Funds of the Department of Budget and Management, Department of Interior and Local Government and National Youth Commission and to all auditing rules and regulations are hereby mandated.


**APPROVING AND DECLARING OPERATIVE THE 2020 SANGGUNIANG
