**APPROVING AND DECLARING OPERATIVE THE ANNUAL BUDGETS FOR
CALENDAR YEAR 2021 OF DIFFERENT BARANGAYS OF BATANGAS CITY**

WHEREAS, a judicious review, evaluation and analysis of each of the Barangay Annual Budgets submitted to the Sangguniang Panlungsod shows substantial compliance with law and all budgetary rules and regulations.

NOW THEREFORE, be it resolved, as it hereby resolves to approve and declare operative the following Annual Barangay Budgets for Calendar Year 2021 to wit:

The budget documents shall form part of the authorized barangay budget.

Any change in the annual budget shall be in accordance with the provisions of Sections 321 and 336 of the Local Government Code.

Compliance with all existing laws, auditing rules and regulations are hereby mandated and shall be the responsibility of the barangay officials.

UNANIMOUSLY APPROVED by the Sangguniang Panlungsod on October 12, 2020.


