DUE TO TYPHOON QUINTA**

WHEREAS, Batangas City was devastated by the Typhoon Quinta which affected Southern Luzon including the Province of Batangas;

WHEREAS, Batangas City was heavily battered and suffered severe damages in agriculture property and infrastructure;

WHEREAS, the City Mayor Beverley Rose A. Dimacuha requests for the confirmation of the declaration placing the entire City of Batangas under a State of Calamity due to “Typhoon Quinta”;

NOW THEREFORE, be it resolved as it is hereby resolved by the Sangguniang Panlungsod in session assembled to declare, as it is hereby declared, a state of calamity in Batangas City.

APPROVED UNANIMOUSLY by the Sangguniang Panlungsod of Batangas City this 27th day of October, 2020.”


