**RESOLUTION NO. 326 S. 2020**

**AUTHORIZING THE OIC-CITY TREASURER OF BATANGAS CITY TO ENTER  
INTO A COMPROMISE AGREEMENT FOR THE SETTLEMENT OF AMOUNT DUE  
TO THE CITY GOVERNMENT OF BATANGAS AS PAYMENT FOR BUSINESS  
TAXES ON INSTALLMENT BASIS**

**WHEREAS**, the economic conditions of the Philippines necessitate the grant to the taxpayers of Batangas City certain mitigation in the payment of their obligations to the City;

**WHEREAS**, due to the ongoing crisis caused by the COVID-19 pandemic, business owners hardly operate their business profitably;

**WHEREAS**, there are numerous taxpayers who could not afford to pay in lump sum their business taxes due to the said state;

**WHEREAS**, to show the concern of the government to its constituents and believing that the grant would also be beneficial to the City, the Sangguniang Panlungsod finds no legal impediment to the approval of this Resolution.

**NOW THEREFORE**, be it resolved as it is hereby resolved, by the Sangguniang Panlungsod of Batangas City, in session assembled, to grant to the OIC- City Treasurer the authority to enter into a compromise agreement with the taxpayers to settle all the dues and penalties for business taxes in installments provided that the agreement will not place the City in a grossly disadvantageous position.
