WHEREAS, a judicious review, evaluation and analysis of Sangguniang Kabataan Barangay Annual Budget for Calendar Year 2020 submitted to the Sangguniang Panlungsod shows substantial compliance with law and all budgetary rules and regulations.

NOW THEREFORE, be it resolved as it hereby resolves, to approve and declare operative the Sangguniang Kabataan Annual Budget for Calendar Year 2020 to wit:

1. Brgy. Poblacion 7 Php 229,767.00

The budget document shall form part of the authorized barangay budget.

Any change in the annual budget shall be in accordance with the provisions of Sections 321 and 336 of the Local Government Code.

Compliance with all existing laws, auditing rules and regulations are hereby mandated and shall be the responsibility of the Sangguniang Kabataan officials.

This Sangguniang Kabataan Annual Budget is therefore considered operative and effective as of January 1, 2020 in accordance with Section 332 of R.A. 7160.



Certified copy of this resolution shall immediately be furnished to the concerned Sangguniang Kabataan, through the Punong Barangay and to the City Budget Officer.
