**APPROVING AND DECLARING OPERATIVE THE 2020 SANGGUNIANG
KABATAAN SUPPLEMENTAL BUDGETS OF VARIOUS BARANGAYS
OF BATANGAS CITY**

WHEREAS, a judicious review, evaluation and analysis of each of the Sangguniang Kabataan Supplemental Budgets submitted to the Sangguniang Panlungsod shows substantial compliance with law and all budgetary rules and regulations.

NOW THEREFORE, be it resolved, as it hereby resolves, to approve and declare operative the Sangguniang Kabataan Supplemental Budgets for the purpose the amount were appropriated:

Certified copy of this resolution shall immediately be furnished to the Sangguniang Kabataan, through the Punong Barangay and to the City Budget Officer.


