**WHEREAS**, a review of the Supplemental Budget for Calendar Year 2020 of Barangay Tabangao Ambulong, Batangas City shows substantial compliance with the provisions of the Local Government Code of 1991;

**NOW THEREFORE**, be it resolved, as it hereby resolves, to approve and declare operative the Supplemental Budget for Calendar Year 2020 for the purpose the amount was appropriated:


