RESOLUTION NO. 406 S. 2020

GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR BEVERLEY ROSE
A. DIMACUHA TO SIGN THE TRIPARTITE MEMORANDUM OF AGREEMENT
WITH THE DEPARTMENT OF HEALTH-CENTER FOR DEVELOPMENT
CALABARZON AND "HEALTH FACILITY" FOR THE "COVID-19 BENEFITS"
OF HEALTH WORKERS

WHEREAS, Section 4(h), of R.A. 11494, or the "Bayanihan to Recover as One Act", authorizes the national government to grant a "COVID-19 Special Risk Allowance" to all public and private health workers (HWs) directly catering to COVID-19 patients for every month that they are serving during the declaration of a state of national emergency;

WHEREAS, the Department of Health (DOH) issued the Memorandum Circular No. 2020-0054 giving information and guidance on Administrative Order Nos. 35 and 36, both dated November 16, 2020;

WHEREAS, the DOH issued the Department Order No. 2020-0725 with subject "Guidelines on the Sub-Allotment and Disbursement of Funds to Centers for Health Development (CHDs) for the Benefits of Health Workers in Response to COVID-19 Health Emergency", and subsequently released the Sub-Allotment Advise (SAA) for this purpose, with SAA No. 20-11-0381;

WHEREAS, CHD CALABARZON has been tasked by the DOH, with the prompt disbursement of funds to cover the benefits of the HWs in response to the COVID-19 health emergency (COVID-19 Benefits);

WHEREAS, the LGU is an established government entity by virtue of R.A. 7160 or the Local Government Code of 1991, and its amendments and holds ownership and exercise administrative control and supervision over the HEALTH FACILITY;

WHEREAS, the HEALTH FACILITY is a public health facility owned by the LGU, employing the services of HWs assigned at designated COVID-19 units, who provide critical and urgent services to respond to the public health emergency during the state of national emergency, and who are eligible recipients of the COVID-19 Benefits covered by the SAA;

NOW THEREFORE, be it resolved as it hereby resolves by the Sangguniang Panlungsod of Batangas City, in session assembled, to grant the authority to the Honorable City Mayor, Beverley Rose A. Dimacuha to sign the Tripartite Memorandum of Agreement with the Department of Health-Center for Health Development CALABARZON and "Health Facility" for the "COVID-19 Benefits" of Health Workers.
