WHEREAS, a judicious review, evaluation and analysis of each of the Sangguniang Kabataan Annual Budgets submitted to the Sangguniang Panlungsod show substantial compliance with law and all budgetary rules and regulations.

NOW THEREFORE, be it resolved as it hereby resolves, to approve and declare operative the following Sangguniang Kabataan Annual Budgets for Calendar Year 2021 to wit:

1. Poblacion 19	Php 245,245.00
2. Liponpon, Isla Verde	242,483.00
3. Mabacong	375,122.00
4. Sta. Clara	1,563,978.00
5. Banaba West	444,019.00
6. Dela Paz Proper	373,330.00

The budget documents shall form part of the authorized Sangguniang Kabataan budget.

Any change in the annual budget shall be in accordance with the provisions of Sections 321 and 336 of the Local Government Code.

Compliance with all existing laws, auditing rules and regulations are hereby mandated and shall be the responsibility of the Sangguniang Kabataan officials.

These Sangguniang Kabataan budgets are therefore considered operative and effective as of January 1, 2021 in accordance with Section 332 of R.A. 7160.
