**APPROVING AND DECLARING OPERATIVE THE 2021 SANGGUNIANG  
KABATAAN ANNUAL BUDGET OF DIFFERENT BARANGAYS  
OF BATANGAS CITY**

**WHEREAS**, a judicious review, evaluation and analysis of the Sangguniang Kabataan Annual Budgets submitted to the Sangguniang Panlungsod show substantial compliance with law and all budgetary rules and regulations.

**NOW THEREFORE**, be it resolved as it hereby resolves, to approve and declare operative the following Sangguniang Kabataan Annual Budgets for Calendar Year 2021 to wit:

The budget documents shall form part of the authorized barangay Sangguniang Kabataan budgets.

Any change in the annual budget shall be in accordance with the provisions of Sections 321 and 336 of the Local Government Code.

Compliance with all existing laws, auditing rules and regulations are hereby mandated and shall be the responsibility of the Sangguniang Kabataan officials.


