**WHEREAS**, an efficient and effective vaccination program against COVID-19 can be achieved through expediting the procurement and administration of vaccines;

**WHEREAS**, with knowledge of the increasing global demands for vaccines, local governments are interested in entering into negotiations with companies authorized by competent authorities in charge of safety and efficacy of the vaccines against COVID-19;

**WHEREAS**, it is hereby prudent for the local government of Batangas City by achieving herd immunity against the virus through the effective and efficient vaccination of its inhabitants.

**NOW THEREFORE**, be it resolved, as it hereby resolves, by the Sangguniang Panlungsod, in session assembled, to authorize the City Mayor Beverley Rose A. Dimacuha to sign the Confidentiality Agreement with Astrazeneca Pharmaceuticals (Phils.) Inc. and with any other authorized Pharmaceutical Company Regarding Covid-19 Vaccine.


