RESOLUTION NO. 50 S.2021

A RESOLUTION AUTHORIZING THE CITY MAYOR BEVERLEY ROSE A.
DIMACUHA TO SIGN THE SPECIFIC IMPLEMENTATION AGREEMENTS FOR
THE PANTAWID PAMILYANG PILIPINO PROGRAM WITH THE DEPARTMENT
OF SOCIAL WELFARE AND DEVELOPMENT (DSWD)

WHEREAS, the Pantawid Pamilyang Pilipino Program (4P'S) was signed into law in 2019 under Republic Act 11310 to alleviate and reduce poverty in the low-income households in the Philippines;

WHEREAS, by virtue of RA 11310, the Pantawid Pamilyang Pilipino Program (4P'S) shall be strengthened by documents indicating the implementation arrangements of the program for the concerned local government unit;

WHEREAS, the Specific Implementation Agreements (SIA) between the Local Government of Batangas City and the Pantawid Pamilyang Pilipino Program (4P'S) shall govern the roles and responsibilities of the local government unit in the hopes of improving the conditions of the poorest constituents under their territorial jurisdiction.

NOW THEREFORE, be it resolved, as it hereby resolves, by the Sangguniang Panlungsod, in Session Assembled, to authorize the City Mayor Beverley Rose A. Dimacuha to sign the Specific Implementation Agreement (SIA) for the Pantawid Pamilyang Pilipino Program with the Department of Social Welfare and Development (DSWD) to ensure that well-being of 4P'S beneficiaries are improved.
