: COVID-19 Vaccination Plan in Batangas City

The Committee on Health called the hearing on March 9, 2021. Members of the Committee are present: Coun. Oliver Macatangay, Chairman, and members Coun. Alleen Grace Montalbo, Coun. Karlos Emmanjuel Buted, Coun. Michael Thomas Pastor, and SK Fed Chair Marjorie Manalo. Also present are Vice Mayor Emilio Francisco Berberabe Jr., Coun. Alyssa Renee Cruz, Coun. Nestor Dimacuha, Coun. Julian Villena, Coun. Gerardo Dela Roca, City Health Officer Dr. Rosanna A. Barrion, CDRRMO Rod Dela Roca and Mr. Jerson Sanchez of the Public Information Office. Member of the Media, Mr. Renz Belda was also present.

FINDINGS:

The Batangas City Government is ready to purchase vaccines under Emergency Use Authorization (EUA) with PhP200 million budget approved by Sangguniang Panlungsod. The said amount is possibly not enough for the population of the City but the City Government shall find all means to provide the necessary supply of vaccines for all through carefully planned vaccination program which shall start with priority groups, particularly the frontline government personnel. At present, there is a problem on shortage of supply of vaccines. The City Government is open to considering the different brands available from different manufacturers. There is also a need to prepare a storage facility for the vaccines once they become available. The City Health Officer emphasized the need to orient and provide the people with correct knowledge about the importance of vaccine. The City Government is coordinating with medical experts in the City to boost the manpower requirement upon arrival of vaccines. The City Disaster Management Team is likewise tapped for this vital undertaking and is in constant coordination with the City IATF.

After the hearing, the outstanding and heartbeat crafted vaccination plan of Batangas City, it was unfolded that the city is well prepared and almost ready for the administration of the vaccine roll out as early as January. Though cascades of questions and inquiries was raised during the committee hearing. Dra. Rosanna Barrion with her expertise brilliantly address and intelligently responded to the questions and inquiries. In addition, CDRRMO officer Rod Dela Roca also made mentioned that they will be in cooperation with the City Health Office with regards to all the matters in COVID -19 Vaccination Plan through the assistance of IMT.

RECOMMENDATIONS:

This Committee therefore recommends the following:

- A continuous dissemination of information about the importance of vaccines to the people of Batangas City should be launched and maintained through the Public Information Office and other media arms;
- 2. The people of Batangas City should be properly informed and updated on the availability of the vaccines and the plans of the city Government on vaccination program;
- 3. The adoption of this committee report.
