WHEREAS, the City Government of Batangas shall purchase COVID-19 vaccines as an integral part of its health program for the benefit and safety of the people of Batangas City;

WHEREAS, the Chief Executive needs authority to enter into purchase agreements with reputable pharmaceutical companies for the acquisition of the vaccines;


