STREET LIGHTS HIGH-END TYPE (FOR THE 6 BARANGAYS OF ISLA VERDE,  
TALUMPOK SILANGAN, TALUMPOK KANLURAN AND MAAPAZ) PROPOSED FOR  
FUNDING UNDER THE LOCAL GOVERNMENT SUPPORT FUND-FINANCIAL  
ASSISTANCE TO LOCAL GOVERNMENT UNITS (LGSF-FALGU) IN THE AMOUNT OF  
PHP 10,000,000.00**

**WHEREAS**, in a letter dated March 9, 2021, the Honorable City Mayor forwarded to the Sangguniang Panlungsod the request for a passage of a resolution endorsing the purchase, delivery and installation of customized street lights high-end type for funding under the Local Government Support Fund-Financial Assistance to Local Government Units (LGSF-FALGU) in the amount of Php 10,000,000.00;



#### COMMENTS:
