RESOLUTION NO. 144 S. 2021

**SUPPORTING THE USE OF SELECTED PUBLIC SCHOOLS OF BATANGAS CITY
AS REVERSE ISOLATION FACILITIES**

WHEREAS, the COVID-19 pandemic continues to afflict significant number of Batangas City’s population filling to excess the isolation facilities provided by the City Government;

WHEREAS, there is an urgent need to identify additional isolation facilities to mitigate the effects of this health crisis in communities and to abide by the basic health protocols issued by the IATF and the DOH;

WHEREAS, public schools are now being eyed as possible isolation facilities;

WHEREAS, in order to allay the fears and unfavorable sentiments of barangay residents, the Sangguniang Panlungsod recommends that public schools which may be tapped as barangay isolation facilities be used for “reverse isolation” whereby the families of COVID-positive patients shall be housed in the facility that, in effect, the identified school-barangay isolation facility shall be used as evacuation centers for the covid-negative family members of covid patients;
