

**EFFECTIVITY.** The approved Sangguniang Kabataan Supplemental Budget shall take effect upon approval by the Sangguniang Kabataan concerned or on the date fixed in the Sangguniang Kabataan Ordinance as provided in Section 20 of R.A. 10742.

Certified copy of this resolution shall immediately be furnished to the Sangguniang Kabataan, through the Punong Barangay and to the City Budget Officer.

**UNANIMOUSLY APPROVED.”**


