
This Sangguniang Kabataan budget is therefore considered operative and effective as of January 1, 2021 in accordance with Section 332 of R.A. 7160.

Certified copy of this resolution shall immediately be furnished to the concerned Sangguniang Kabataan, through the Punong Barangay and to the City Budget Officer.


