**APPROVING AND DECLARING OPERATIVE THE SANGGUNIANG KABATAAN
SUPPLEMENTAL BUDGETS FOR CALENDAR YEAR 2021 OF DIFFERENT
BARANGAYS OF BATANGAS CITY**

WHEREAS, a judicious review, evaluation and analysis of the Sangguniang Kabataan Supplemental Budgets for CY 2021 of different Barangays submitted to the Sangguniang Panlungsod show substantial compliance with law and all budgetary rules and regulations.

NOW THEREFORE, be it resolved, as it hereby resolves, to approve and declare operative the Sangguniang Kabataan Supplemental Budgets for CY 2021 of different Barangays for the purpose the amount were appropriated:

EFFECTIVITY. The approved Sangguniang Kabataan Supplemental Budget shall take effect upon approval by the Sangguniang Kabataan concerned or on the date fixed in the Sangguniang Kabataan Ordinance as provided in Section 20 of R.A. 10742.

Certified copy of this resolution shall immediately be furnished to the Sangguniang Kabataan, through the Punong Barangay and to the City Budget Officer.


