INTRODUCTION

Referred to the Committee on Codification of Laws is the proposed ordinance entitled: An Ordinance Enacting the Code of General Ordinances of the City of Batangas 2021, authored by Vice Mayor Emilio Francisco A. Berberabe, and sponsored by the undersigned Coun. Lorenzo A. Gamboa Jr. and co-sponsored by Coun. Nestor E. Dimacuha and Coun. Karlos Emmanjuel A. Buted.

The Committee conducted a committee hearing via zoom on August 10, 2021 at 11:00 o'clock in the morning.

COMMENTS AND SUGGESTIONS

Vice Mayor Emilio Francisco Berberabe expressed his gratitude to all who exerted effort to craft the Code of General Ordinances. He eloquently and intelligently explained the importance of the codification, confidently gave a brief overview of the content and coverage which justified the exclusion of certain existing ordinances

Atty. Deguito states that he received the copy the Draft of the Codification of General Ordinances no other foreseeable problem as he observed that it is well written, except for some clerical errors. He requested to be afforded at least a week to review all of the 317 pages. He also expressed his concern over the issue of expenses and he advised the Sangguniang Panlungsod to take precaution.

Atty. Oliva Telegatos assured Atty. Deguito that there will be no problem with regards to collection and costing, and that only the expenses for the printing will be charged.
