APPOINTMENT OF MRS. AMELIA P. REYES AS CITY GOVERNMENT DEPARTMENT HEAD I (CITY MARKET ADMINISTRATOR) IN THE OFFICE OF THE CITY MARKET

COMMENTS:

The subject request for the appointment of the above person was referred to the Joint Committee on Laws, Rules and Regulations and Committee on Civil Service for its consideration during the Regular Session on August 3, 2021.

The Committee held a hearing thru Zoom on August 17, 2021 and in attendance were the following:

From Human Resource Management and Development Office: Mrs. Aurea Castillo; from City Market: Mrs. Amelia P. Reyes. Also present are the Chairpersons Coun. Alyssa Renee A. Cruz (Laws) and Coun. Michael Thomas Pastor (Civil Service) and committee members Coun. Gerardo A. Dela Roca, Coun. Julian B. Villena, Coun. Nelson Chavez, Coun. Oliver Z. Macatangay, and Coun. Nestor E. Dimacuha. The Vice Mayor Emilio Francisco Berberabe Jr. and other members of the Sangguniang Panlungsod were also present.

A scrutiny of the qualifications of Mrs. Reyes shows that she possesses the qualifications and none of the disqualifications for the office for which she is appointed. The function of concurrence by the Sangguniang Panlungsod on the appointment is to determine whether the appointee is possessing of all the qualifications and none of the disqualifications as provided by the Code, law or ordinance. Any arbitrary or whimsical withholding of the required concurrence despite the fact that the appointee is qualified, would amount to an encroachment into the prerogative of and discretion of the appointing authority.
