**RESOLUTION NO. 234 S. 2021**

**RESOLUTION ALLOWING THE CENTER FOR HEALTH DEVELOPMENT (CHD)  
CALABARZON TO CONSTRUCT THE SUPER FAMILY HEALTH CENTER IN  
BATANGAS CITY**

**WHEREAS**, Batangas City have received a grant from the Regional Office of Center for Health Development (CHD), fund for the construction of Super Family Health Center;

**WHEREAS**, as per the request of the Lone District Representative of Batangas City, the construction of the said center will be completed along the San Isidro Evacuation Center. The contract amounting to P15 Million Pesos will be allotted for the infrastructure of the said center, containing an area of 498 square meters. There will be a separate budget for the equipment and other furniture. Services of the said center include Clinical Laboratory, XRAY with ECG, Check-up and Dental Clinic, while there is no birthing facility included;

**WHEREAS**, the City Government of Batangas has vigorously exerted more effort to improve and expand the public health system at all levels;

**WHEREAS**, under the health program of the city government, residents of Batangas City are encouraged to approach barangay health stations/centers for minor health concerns. If necessary, these community health centers will refer cases to the regular health centers and later to the Super Family Health Centers;



RESOLUTION TO ALLOW THE CENTER FOR HEALTH DEVELOPMENT (CHD) CALABARZON TO  
CONSTRUCT THE SUPER FAMILY HEALTH CENTER IN BATANGAS CITY

COMMENTS/RECOMMENDATIONS

The subject request for the passage of a resolution was referred to the Committee on Laws, Rules and Regulations for its consideration during the Regular Session on August 10, 2021.

The Committee held a hearing via ZOOM on August 17, 2021 and in attendance were the following:

From City Health Office: Dra. Rosanna Carmelita Barrion and Dra. Angela Gracia Alegre; from CEO: Architect Jose G. Palas, from CDRRMO: Mr. Rodrigo Dela Roca and from Regional Office of CHD: Engr. Jla Angeles. Also present are the Chairpersons Coun. Alyssa Renee A. Cruz (Laws) and Coun. Oliver Z. Macatangay (Health) and the committee members: Coun. Gerardo Dela Roca, Coun. Julian Villena, Coun. Oliver Z. Macatangay, Coun. Nelson J. Chavez, Coun. Maria Aleth Lazarte, Coun. Aileen Grace A. Montalbo, Coun. Karlos Emmanjuel Buted, Coun. Michael Thomas Pastor, Coun. Lorenzo A. Gamboa Jr. and SK Federation President Marjorie A. Manalo. The Vice Mayor Emilio Francisco Berberabe Jr. and other members of the Sangguniang Panlungsod, Councilors Nestor Dimacuha, Isidra M. Atienza, and ABC President Angelito Dondon Dimacuha were also present.

The Batangas City have received a grant from the Regional Office of Center for Health Development, fund for the construction of Super Family Health Center. As per the representative of CHD, posting for bidding will be done after the preparation of estimates. The architectural design was already accomplished while the structural design is still on-going. Two weeks after the approval of the latter, the CHD Office will be open for free bid conference or free procurement.
