**APPROVING AND DECLARING OPERATIVE THE SANGGUNIANG KABATAAN

WHEREAS, a judicious review, evaluation and analysis of the Sangguniang Kabataan Supplemental Budgets for CY 2021 of different barangays submitted to the Sangguniang Panlungsod show substantial compliance with law and all budgetary rules and regulations.


