**APPROVING AND DECLARING OPERATIVE THE 2022 ANNUAL
BUDGETS OF DIFFERENT BARANGAYS OF BATANGAS CITY**

WHEREAS, a judicious review, evaluation and analysis of each of the Barangay Annual Budgets submitted to the Sangguniang Panlungsod show substantial compliance with law and all budgetary rules and regulations.

NOW THEREFORE, be it resolved as it hereby resolves, to approve and declare operative the following Annual Barangay Budgets for Calendar Year 2022 to wit:

1. Poblacion 18	P 3,298,537.00
2. Balagtas	11,943,608.00
3. Bolbok	23,701,644.00
4. Malitam	11,802,744.00
5. Pallocan Silangan	6,745,189.00

The budget documents shall form part of the authorized barangay budget.

Any change in the annual budget shall be in accordance with the provisions of Sections 321 and 336 of the Local Government Code.

Compliance with all existing laws, auditing rules and regulations are hereby mandated and shall be the responsibility of the barangay officials.


