**APPROVING AND DECLARING OPERATIVE THE SANGGUNIANG KABATAAN  
SUPPLEMENTAL BUDGET FOR CALENDAR YEAR 2021 OF BARANGAY

**WHEREAS**, a judicious review, evaluation and analysis of the Sangguniang Kabataan Supplemental Budget for CY 2021 of Barangay Sta. Clara, Batangas City submitted to the Sangguniang Panlungsod shows substantial compliance with law and all budgetary rules and regulations.


