**RESOLUTION UPDATING AND ADOPTING THE LIST OF CULTURAL
PROPERTIES OF BATANGAS CITY 2021**

WHEREAS, Sections 14, 15, 16, and 17, Article XIV of the 1987 Philippine Constitution declare that the State shall foster the preservation, enrichment and dynamic evolution of a Filipino culture based on the principle of unity in diversity in a climate of free artistic and intellectual expression;

WHEREAS, in compliance to Republic Act 10066, otherwise known as the “National Cultural Heritage Act of 2009”, and Department of Interior and Local Government-National Commission for Culture and the Arts (DILG-NCCA) Joint Memorandum Circular No. 2021-001 dated May 07, 2021, local government units were instructed to comply with the NCCA guidelines relative to the preparation of the local cultural inventory (LCI) and its subsequent submissions to the Commission for inclusion in the Philippine Registry of Cultural Property (PRECUP);

WHEREAS, in the pursuit of cultural preservation as a strategy for maintaining Filipino and Batangueño identity, protecting, preserving, conserving and promoting local cultural heritage, properties and histories, and the ethnicity of local communities shall be of primordial consideration;


