RESOLUTION NO. 302 S. 2021

**APPROVING AND DECLARING OPERATIVE THE SANGGUNIANG KABATAAN
SUPPLEMENTAL BUDGETS FOR CALENDAR YEAR 2021 OF DIFFERENT
BARANGAYS OF BATANGAS CITY**

WHEREAS, a judicious review, evaluation and analysis of the Sangguniang Kabataan Supplemental Budgets for CY 2021 of different Barangays submitted to the Sangguniang Panlungsod shows substantial compliance with law and all budgetary rules and regulations.

NOW THEREFORE, be it resolved, as it hereby resolves, to approve and declare operative the Sangguniang Kabataan Supplemental Budgets for CY 2021 of different Barangays for the purpose the amounts were appropriated:

1. Poblacion 24	Php 356,482.73
2. Ilijan	970,000.00
3. Soro-soro Ilaya	195,000.00

RESPONSIBILITY. The execution of the budget and the accountability therefore shall be vested primarily in the Sangguniang Kabataan (SK) Chairman.

COMPLIANCE. Compliance to the provisions of Joint Memorandum Circular No. 1 S. 2019 or the Guidelines on the Appropriation, Release, Planning and Budgeting Process of Sangguniang Kabataan (SK) Funds of the Department of Budget and Management, Department of Interior and Local Government and National Youth Commission and to all auditing rules and regulations are hereby mandated.

APPROVING AND DECLARING OPERATIVE THE SANGGUNIANG KABATAAN SUPPLEMENTAL BUDGETS FOR CALENDAR YEAR 2021 OF DIFFERENT BARANGAYS OF BATANGAS CITY

EFFECTIVITY. The approved Sangguniang Kabataan Supplemental Budget shall take effect upon approval by the Sangguniang Kabataan concerned or on the date fixed in the Sangguniang Kabataan Ordinance as provided in Section 20 of R.A. 10742.

Certified copy of this resolution shall immediately be furnished to the Sangguniang Kabataan, through the Punong Barangay and to the City Budget Officer.


