**RESOLUTION NO. 308 S. 2021**

**APPROVING AND DECLARING OPERATIVE THE SANGGUNIANG KABATAAN  
SUPPLEMENTAL BUDGETS FOR CALENDAR YEAR 2021 OF DIFFERENT  
BARANGAYS OF BATANGAS CITY**

**WHEREAS**, a judicious review, evaluation and analysis of the Sangguniang Kabataan Supplemental Budgets for CY 2021 of different Barangays submitted to the Sangguniang Panlungsod shows substantial compliance with law and all budgetary rules and regulations.

**NOW THEREFORE**, be it resolved, as it hereby resolves, to approve and declare operative the Sangguniang Kabataan Supplemental Budgets for CY 2021 of different Barangays for the purpose the amounts were appropriated:
