**APPROVING AND DECLARING OPERATIVE THE SANGGUNIANG KABATAAN
SUPPLEMENTAL BUDGET FOR CALENDAR YEAR 2021 OF BARANGAY

WHEREAS, a judicious review, evaluation and analysis of the Sangguniang Kabataan Supplemental Budget for CY 2021 of Barangay Talumpok Kanluran, Batangas City submitted to the Sangguniang Panlungsod shows substantial compliance with law and all budgetary rules and regulations.


Certified copy of this resolution shall immediately be furnished to the Sangguniang Kabataan, through the Punong Barangay and to the City Budget Officer.
