**APPROVING AND DECLARING OPERATIVE THE 2022 SANGGUNIANG  
KABATAAN ANNUAL BUDGETS OF DIFFERENT BARANGAYS OF  
BATANGAS CITY**

**WHEREAS**, a judicious review, evaluation and analysis of each of the Sangguniang Kabataan Annual Budgets submitted to the Sangguniang Panlungsod shows substantial compliance with law and all budgetary rules and regulations.

**NOW THEREFORE**, be it resolved as it hereby resolves, to approve and declare operative the following Sangguniang Kabataan Annual Budgets for Calendar Year 2022 to wit:
