**APPROVING AND DECLARING OPERATIVE THE SUPPLEMENTAL BUDGETS
FOR CALENDAR YEAR 2021 OF BARANGAY POBLACION 05 AND
BALETE, BATANGAS CITY**

WHEREAS, a review of the Supplemental Budgets for Calendar Year 2021 of Barangay Poblacion 05 and Balete, Batangas City shows substantial compliance with the provisions of the Local Government Code of 1991;

NOW THEREFORE, be it resolved, as it hereby resolves, to approve and declare operative the Supplemental Budgets for Calendar Year 2021 for the purpose the amount was appropriated:


Certified copy of this resolution shall immediately be furnished to the concerned Sangguniang Barangay, through the Punong Barangay and to the City Budget Officer.
