On November 23, 2021 this office received a copy of a Notice on Appeal from Atty. John Rafael T. De La Cruz, JD, Counsel for the respondent Barangay Captain wherein he informed the Sangguniang Panglunsod that he is appealing the decision before the Sangguniang Panglalawigan.

While it may be true that the decision of the Sangguniang Panglungsod may be executed pending appeal, there is a possibility that the respondent Barangay Captain may be exonerated and the decision of the Sangguniang Panglungsod reversed. In such a case, the respondent Barangay Captain will have to be paid the salaries and emoluments he did not receive during the period of his suspension.

To avoid this situation, it is recommended that the enforcement of the decision of the Sangguniang Panglungsod be held in abeyance until such time that the appeal of Respondent Barangay Captain is resolved by the Sangguniang Panlalawigan.
