**RESOLUTION NO. 348 S. 2021**

**EARNESTLY REQUESTING MERALCO AND PRIME WATER TO FACILITATE  
UTILITY SERVICES FOR PUROK 6, SITIO SALALAK AND SITIO MAKUKAK,  
STA. CLARA IBABA, BATANGAS CITY**

**WHEREAS**, residents of Purok 6, Sitio Salalak and Sitio Makukak, Sta. Clara Ibaba, Batangas City sought the assistance of the Sangguniang Panlungsod for the alleviation of their poor living condition brought about by the lack of services of basic utilities such as electricity and potable water;

**WHEREAS**, Purok 6, Sitio Salalak and Sitio Makukak were gravely affected by the fire that razed their community to the ground in 2019 which resulted to the loss of their homes and these basic facilities;

**WHEREAS**, these communities were not able to recover the services of MERALCO and Prime Water due to lack of valid titles to the property they are occupying;

**WHEREAS**, Purok 6, Sitio Salalak and Sitio Makukak are sitting on a contested property which fact complicates the completion of documentary requirements for the installation of services to homes therein;

**EARNESTLY REQUESTING MERALCO AND PRIME WATER TO FACILITATE UTILITY SERVICES FOR PUROK 6, SITIO SALALAK AND SITIO MAKUKAK, STA. CLARA IBABA, BATANGAS CITY**

**WHEREAS**, for the interest of public welfare and compassionate social justice, there is a need to provide the residents of these communities access to basic services of utility companies;

**NOW THEREFORE**, be it resolved at it is hereby resolved by the Sangguniang Panlungsod in session assembled, to request as it hereby **EARNESTLY REQUESTS MERALCO AND PRIME WATER TO EXTEND THEIR ASSISTANCE AND COOPERATION TO PROVIDE PUROK 6, SITIO SALALAK AND SITIO MAKUKAK WITH ELECTRIC AND WATER SERVICES.**


