**RESOLUTION NO. 365 S. 2021**

**AUTHORIZING THE CITY MAYOR TO GRANT SERVICE RECOGNITION  
INCENTIVE TO BATANGAS CITY GOVERNMENT EMPLOYEES  
FOR FISCAL YEAR 2021**

**WHEREAS**, His Excellency, President Rodrigo Roa Duterte issued Administrative Order No. 45 dated 24 December 2021 authorizing the grant of one-time Service Recognition Incentive to government employees for Fiscal Year 2021;

**WHEREAS**, AO No. 45 aims to “provide reasonable incentives and assistance to public servants, who are impacted not only by the pandemic but also by various calamities”;

**WHEREAS**, Section 6 of AO No. 45 provides that the grant of the one-time SRI to employees in the local government units shall be determined by the respective Sanggunians depending on the LGU’s financial capacity, subject to the PS limitation in the LGU budget under the Local Government Code of 1991, and the conditions set forth in Section 2 of the same AO No. 45, at a uniform rate not exceeding Ten Thousand Pesos (PhP 10,000.00) chargeable against FY 2021 local government funds;

**WHEREAS**, the City Mayor, through the City Budget Officer, certifies the availability of fund for the grant of SRI to Batangas City Government employees, and that the grant does not exceed the PS limitation provided under the Local Government Code of 1991;

**AUTHORIZING THE CITY MAYOR TO GRANT SERVICE RECOGNITION INCENTIVE TO BATANGAS CITY GOVERNMENT EMPLOYEES FOR FISCAL YEAR 2021**

**WHEREAS**, there is a need to authorize the City Mayor to grant Service Recognition Incentive to Batangas City Government Employees for FY 2021;

**NOW, THEREFORE**, be it **RESOLVED** as it is hereby resolved by the Sangguniang Panlungsod in session assembled, to **AUTHORIZE** as it hereby authorizes the City Mayor Beverley Rose A. Dimacuha to grant Service Recognition Incentive to Batangas City Government employees, subject to the conditions set forth in AO No. 45, the Local Government Code of 1991, and all pertinent accounting and auditing rules and regulations.


