**AUTHORIZING THE CITY MAYOR TO GRANT GRATUITY PAY TO CONTRACT
OF SERVICE AND JOB ORDER WORKERS IN BATANGAS CITY GOVERNMENT
FOR FISCAL YEAR 2021**

WHEREAS, His Excellency, President Rodrigo Roa Duterte issued Administrative Order No. 46 dated 29 December 2021 authorizing the grant of Gratuity Pay to Contract of Service (COS) Employees and Job Order (JO) Workers in Government for Fiscal Year 2021 in the amount not exceeding Five Thousand Pesos (PhP5,000.00);

WHEREAS, AO No. 46 intends to provide COS and JO workers recognition of their hard work in implementing programs, projects and activities, including those which are part of the emergency COVID-19 response efforts of the government;

WHEREAS, Section 5 of AO No. 46 enjoins Local Government Units to adopt the grant of Gratuity Pay to workers whose services are engaged through Contract of Service and Job Order, utilizing appropriate and available funding sources, and that the corresponding supplemental budget shall be enacted by the respective Sanggunian within FY 2021;

WHEREAS, the City Mayor, through the City Budget Officer, certifies the availability of fund for the grant of Gratuity Pay to Batangas City Government Job Order employees;

WHEREAS, there is a need to authorize the City Mayor to grant Gratuity Pay to Batangas City Government Job Order Employees for FY 2021;



