**APPROVING THE REQUEST OF THE CITY MAYOR, EDUARDO B. DIMACUHA  
FOR THE AUTHORIZATION TO RELEASE FINANCIAL ASSISTANCE  
OF ONE MILLION PESOS (P1,000,000.00) OF THE LDRRM FUND/5%  
CALAMITY FUND TO SUPPORT THE CITIES OF  
CEBU AND BOHOL**

**WHEREAS**, the amount requested by the City Mayor is in consonance with Section 21 of RA 10121 and Rule 18 Section 1 of its Implementing Rules and Regulations which states that "Upon recommendation of the LDRRMO and approval of the Sanggunian concerned, the LDRRMC may transfer an amount of the LDRRM Fund to support disaster risk reduction work and other LDRRMC's which are declared under state of calamity;

**WHEREAS**, the amount requested will help build disaster resilience of these two cities and institutionalizing measures for rehabilitation program for their constituents in accordance with the existing operational plans, directives and orders issued in connection with the occurrence of calamities;


**NOW THEREFORE**, be it resolved by the Sangguniang Panlungsod in session assembled to approved as it hereby approves, the request of the City Mayor for the authorization to release financial assistance of One Million Pesos (P1,000,000.00) , (P500,000.00 each) of the LDRRM Fund/5% Calamity Fund to support the rehabilitation activities of the provinces of Cebu and Bohol which were declared under a state of calamity.


