WHEREAS, the Honorable City Mayor in his letter dated September 23, 2013 requested for the abolition of one (1) Agricultural Technologist SG-10, one (1) Aquacultural Technologist SG – 10 and one (1) Clerk 1 SG-3 positions and the creation of one (1) Agricultural Technician II G-8, one (1) Animal Keeper II G-6 and one (1) Farm Worker II G-4 positions in the Office of the City Veterinary and Agricultural Services due to vacant positions of the said office. The aforementioned items for abolition had been vacated and there are no qualified regular employees from the said office to fill up the vacancies. The creation of the three (3) new items is requested for there are three (3) qualified employees from the said office who are performing their duties very satisfactorily;

FIRST - Abolition of one (1) Agricultural Technologist SG = 10, one (1) Aquacultural Technologist SG = 10 and one (1) Clerk 1 SG = 3 positions and the creation of one (1) Agricultural Technician II G-8, one (1) Animal Keeper II G-6 and one (1) Farm Worker II G = 4 positions in the Office of the City Veterinary and Agricultural Services.
