**RESOLUTION NO. 2 S. 2013**

**APPROVING THE ABOLITION OF POSITION AND CREATION OF TWO NEW  
POSITIONS IN THE OFFICE OF THE CITY MAYOR, BUSINESS PERMIT  
AND LICENSE DIVISION**

**WHEREAS**, the Honorable City Mayor in her indorsement requested the abolition and creation of certain positions in the BPLD of the Office of the City Mayor.

**WHEREAS**, the good of public service and promotion of the general welfare necessitate the approval of the request of the City Mayor.

**NOW, THEREFORE**, BE IT RESOLVED TO APPROVE, AS IT HEREBY APPROVES, the ABOLITION of the position LICENSE OFFICER II (LOII) and CREATION of ADMINISTRATIVE ASSISTANT I (SG7) and ADMINISTRATIVE AIDE IV (SG4) in the Business Permits and License Division (BPLD), Office of the City Mayor.

**RESOLVED FURTHER**, that the abolition and creation of positions shall be subject to the following conditions:

1. Appointment shall be based on the qualification standards provided by civil service laws, rules and regulations.
2. Abolition of position shall not affect any employees right to tenure in office protected by the Civil Service Law and Rules and Regulations issued by the Civil Service Commission.
