Any change in the annual budgets shall be in accordance with the provisions of Section 321 and 336 of the Local Government Code.

Compliance with all existing laws, auditing rules and regulations are hereby mandated and shall be the responsibility of the barangay officials.

These annual barangay budgets for CY 2013 are therefore considered operative and effective as of January 1, 2013 in accordance with Section 332 of R.A. 7160.
