RESOLUTION NO. 48 S.2013

**RESOLUTION REQUESTING THE DEPARTMENT OF EDUCATION DIVISION OF
BATANGAS CITY TO STUDY THE POSSIBILITY OF PUTTING UP ALANGILAN
NATIONAL HIGH SCHOOL IN BARANGAY ALANGILAN, BATANGAS CITY,
AND ENDORSING AND SUPPORTING THE ESTABLISHMENT OF THE
SAME IF SO WARRANTED**

WHEREAS, Republic Act 6655 otherwise known as the Free Public Secondary Education Act of 1988 provides for the creation of free public secondary education to all the citizens of the Republic of the Philippines and the provision of a comprehensive and quality education.

WHEREAS, Batas Pambansa Bilang 232 also enumerated the duties of the State in providing free public Secondary Education to all qualified citizens of the Philippines;

WHEREAS, on August 19, 2011 Barangay Alangilan submitted a resolution seeking funds for the establishment of a Barangay High School and another resolution was filed on February 13, 2012 by Councilor Dexter Buted asking the Local School Board to include in their priorities the establishment of an Annex of Batangas National High School;

WHEREAS, both resolutions filed will not be acted by proper authorities since there is a standard process set by the Department of Education for the establishment of a secondary school which must be considered, hence, a resolution seeking a study on the possibility of putting up a secondary school is necessary;

WHEREAS, Barangay Alangilan is a component barangay of the City of Batangas located in the northern part of the City;

WHEREAS, Barangay Alangilan and its adjacent barangays namely, Balagtas, Kumintang Ilaya and Kumintang Ibaba have an estimated population of 45,000 for the year 2012;

WHEREAS, based on the information gathered from proper authorities, thousands of students of Batangas National High School are coming from Barangay Alangilan and its adjacent barangays, hence, establishment of a National High School in the said Barangay is very timely and practicable and also to encourage more out-of-school-youth to enroll in secondary level;


WHEREAS, the host barangay has manifested their full support in the initial plan to assess, evaluate and consequently for the initial operation of the said Secondary School;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED by the Sangguniang Panlungsod of Batangas City in session assembled to request the Department of Education Division of Batangas City to study the possibility of putting up Alangilan National High School in Barangay Alangilan, Batangas City and endorsing and supporting the establishment of the same if so warranted.


